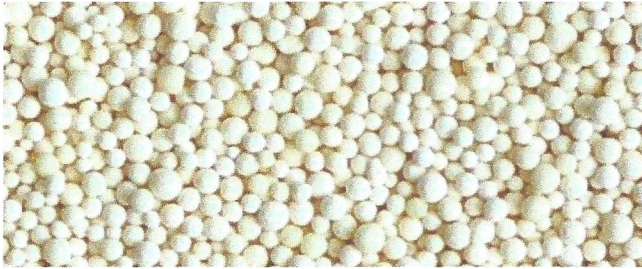

FILTERSORB® SP3 comes with direct contact with the drinking water and hence has been tested multiple times from different countries following international and their regional norms to certify FILTERSORB® SP3 absolutely safe for drinking water applications. FILTERSORB® SP3 has obtained the following certifications related to drinking water acceptance:
  - FILTERSORB® SP3 is certified under **ANSI/NSF 61** and **ANSI/NSF 372** from WQA, USA.
  - FILTERSORB® SP3 is **BS 6920:2000** and **WRAS** (British Standard, UK) certified.
  - FILTERSORB® SP3 is tested to meet **MSZ 448-36:1985** standard (Hungary).
  - FILTERSORB® SP3 is certified from Department of Environmental Hygiene (Poland).
3. SP3 has no toxic components and does not bio-accumulate in nature.
4. SP3 has no composition to aggravate any kind of organic fouling. To keep in media clean during the service period, the inlet water must be treated according to the manufacturer's guideline. To protect the media from such kind of organic fouling materials, pre-filtration of the inlet water with good quality carbon block is strongly recommended.
